Government in G.O.Rt.No.421, HE(IE.I) Department,dt.04.06.2001,have permitted for preservation of proportionate leave to Junior Lecturers who were prevented from availing summer vacation due to their involvement in conduct of examination, census duty and election duty and also accord sanction for preservation of proportionate E.L`s to the Junior Lecturers for reduction the summer vacation period due to increase of working days from 180 to 226.

Further, the Secretary, Board of Intermediate Education, A.P, Hyderabad in his letter, dt.07.06.2011, has stated that I.P.E. Advanced Supplementary. Examinations May / June 2011 were conducted from 27.05.2011 to 04.06.2011 and as per the schedule, the personnel who were allotted examination work, were directed to take up the duties three (03) days before the schedule i.e. from 24.05.2011.

In view of the Government orders cited above, all the Regional Joint Director`s of Intermediate Education and the Principals of Government Junior Colleges in the state are permitted to preserve **03 Days** of Earned Leave only to the Principals / Junior Lecturers / Physical Directors / Librarians working in Government Junior Colleges in the state who were involved in conduct of Intermediate Public Advanced Examinations May / June 2011 in summer vacation duly obtaining the necessary attendance certificates.

The Regional Joint Director`s of Intermediate Education / Principals of Government Junior Colleges in the state are requested to make necessary entries in the service registers of the incumbents to that effect.
